## JACL, the Convention and the Budget

As the Governor of the Pacific Northwest District of JACL and what they call the Governor's Caucus Chair, I get the privilege and duty of attending the budget meetings prior to the National Board meetings. The most recent board meeting was held in San Francisco on April 9 and 10, and the budget was the main item on the agenda.

As you may have read in the *Pacific Citizen*, the board vote on endorsing the budget to go to the National Council at convention (where all the chapters get to vote on it) was not unanimous, but then again, budget votes have never been unanimous in the ten years I've been doing this.

The current points about the endorsed budget include:

- It's balanced
- It includes dues increases for Regular members (\$5), Couple/family members (\$10), and 1000 and Century Club memberships (\$25). Other membership categories (students and spouse) remain the same.
- It keeps the printed version of the *Pacific Citizen* thru at least 2012
- The most contentious issue is that it moves the *Pacific Citizen* operation from Los Angeles to San Francisco, a strategic consolidation (in my opinion) that the organization must do to have a chance to survive.

The key driver for tight budgets at National JACL has been changes in membership. In 1999, we had 22,000 members. In 2010 we have about 14,000. During that time, they've reduced the

staff in both San Francisco and Washington DC by about 40%. There are 14 staff members left in JACL - five of those are in Los Angeles, where they publish the *Pacific Citizen*. The portion of membership dues that goes to creating and distributing the *Pacific Citizen* used to be \$12 in 1999, but in 2009 it was over \$22 and, with the current budget through 2012, it will be well over \$25.

For these reasons, I think it's clear that National JACL needs to streamline facilities right now in the budget for 2011 and 2012. If you look at the total budget, there are only two places to make a real difference - cut the number of people or cut occupancy costs. Of course, if you cut the number of people, you also have to cut some of the projects and missions that those people are working on.

Cutting facilities isn't fun either. In my last tour of duty in the Army, I was in charge of cutting some logistics bases around the United States to cut costs and make consolidations to accommodate a smaller Army. From a business perspective, it made sense to close a depot in California that rebuilds radios which costs twice as much to operate as the one in Pennsylvania. When that kind of decision gets made, it is difficult for the folks at the closing installation. Although very often they are given the opportunity to follow their job to the new location, most decide to look for work locally instead of moving their families, certainly an understandable decision.

For the Army, the decision revolved around the question, "Do you spend money for bases you don't need, or do you spend those funds on the latest equipment that the soldiers need?" For JACL, the decision is similar: "Do you consolidate to a leaner organization to accomplish the goals that your membership believes is important, or do you let

## JACL Expresses Concern Over Arizona Immigrant Law

The Japanese American Citizens League (JACL) expresses deep concern that Governor Jan Brewer of Arizona signed into law today a measure that would allow law enforcement officers to detain anybody “if there is reason to suspect they are illegal immigrants.”

JACL is the oldest and largest Asian American civil and human rights organization in the nation. Restrictive and punitive immigration laws against Asians were the prime reason for the JACL to be organized in 1929. Since that time, the JACL has fought for fair immigration laws that did not discriminate against one specific group of people.

The National Executive Director of the JACL, **Floyd Mori**, said upon hearing of the signing of the bill, “This legislation essentially puts a target on the back of anybody who may be viewed as an im-

migrant, whether or not they are citizens of the United States. This is alarming to those of us of color who are citizens but are often pegged as foreigners simply because of our ethnic heritage.

In 1942, Japanese Americans were put into concentration camps simply because of their race. This was contrary to basic Constitutional guarantees of fair and equal treatment under the law. This new Arizona law repeats the same error of that 1942 action by the federal government. People of a particular ethnic heritage will be the target of law enforcement simply because of the way they look. This is the worst case of racial profiling since World War II that we could imagine, and the government of Arizona is making the same mistake the federal government made in 1942, which caused many people to suffer greatly through no

fault of their own.”

**Larry Oda**, the JACL's National President, stated: “The JACL was opposed to the legislation and continues to oppose its implementation as a law. Many innocent people will experience difficulties and hardship simply because of their ethnic heritage. While Governor Brewer has cited the border problems as a prime reason for signing the law, it is obvious that the impact will be felt largely in Hispanic communities whether people are citizens or not. It is a shame that politics of fear have won out over the principles of fairness and compassion that have made us the great country we are.”

The Japanese American Citizens League (JACL) has announced that the winner of this year's Minoru Yasui Oratorical Competition will receive two round trip tickets to Japan. All Nippon Airways (ANA) has donated flight and hotel arrangements.

The Minoru Yasui Oratorical Competition is named in memory of Minoru Yasui, an attorney and civil rights activist. Prior to the internment, Min Yasui tested the constitutionality of the curfew orders that were imposed against Japanese Americans. Though the Supreme Court of the United States eventually upheld

the constitutionality of the curfew, Min Yasui never wavered in his pursuit of social justice for all Americans. During the 1980s, Min Yasui was an articulate voice in leading JACL's successful campaign to obtain redress for the injustice of the internment.

Contestants in the oratorical competition will answer the questions: What can the Asian Pacific American community and the JACL do to inspire and create change to meet the needs of America's current sociopolitical landscape? President Barack Obama inspired and motivated a nation with a simple

word -- change. As our nation still faces economic turmoil, wars abroad, as well as damaged health care and immigration systems, "change" has never been more welcome.

This year, the JACL will hold its 41st National Convention, in Chicago, IL from June 30-July 4, 2010 at the Swisshotel in the heart of downtown Chicago.
